1 Preface

This policy outlines the prescription, dispensing, administration, supply, storage, disposal and distribution of all medications in Justice Health and Forensic Mental Health Network (the Network) and the mandatory compliance with Ministry of Health (the Ministry) policy directives and guidelines, State Legislation and Network guidelines, procedures and safe work practices.

Guidelines and procedures for the safe and quality use of all medications within the Network are developed and approved under the auspices of the Network Drugs and Therapeutics Committee which includes clinicians from pharmacy, medical and nursing professions.

The Network Medication Guidelines, Prescribing Formulary, Nurse Initiated Medication Protocols, Standing Orders Protocol and all other specialised medication protocols, procedures and guidelines have been developed and approved to provide all clinical staff with a comprehensive guide to the supply, prescription, administration, storage and disposal of medication in the Network.

2. Policy Content

2.1 Mandatory Requirements

The Network Medication Guidelines, Prescribing Formulary, Nurse Initiated Medication Protocols, Standing Order Protocols and all other specialised medication protocols, procedures and guidelines incorporate the requirements of the NSW [Poison and Therapeutics Goods Act \(1966\)](#), [Poisons and Therapeutic Goods Regulations \(2008\)](#), and Ministry [PD2013_043 Medication Handling in NSW Public Health Facilities](#).

The Network Medication Guidelines and associated documents are available on the Network [Intranet](#), and staff must refer to these for all procedures relating to the management of medications.

2.2 Implementation - Roles & Responsibilities

All staff must ensure that their practice is informed by the Network Medication Guidelines and associated documents and should refer to them regularly to ensure compliance with these documents.

3. Procedure Content

The Network Medication Guidelines and associated documents must be regularly reviewed by the Network Drugs and Therapeutics Committee which includes clinicians from pharmacy, medical and nursing professions.

3.1 Guidelines and Procedures Information Source

Ministry policy directives and guidelines and the Network protocols, procedures, guidelines, and safe work practices can be accessed via the Network Intranet.

3.1.1 Accessibility of Guidelines and Procedures

All staff must have electronic access to Ministry policy directives and guidelines and the Network protocols, procedures, guidelines and safe work practices.

3.1.2 Guideline and Procedure Compliance

Protocol, Procedure and Guidelines compliance must be regularly undertaken through structured observational audits by the Network Drugs and Therapeutics Committee. Longitudinal review of compliance performance and associated action plans must be undertaken regularly.

Should

Indicates a recommended action to be followed unless there are sound reasons for taking a different course of action
